1. Payment in full must be received BEFORE the start date of each program in order to secure your child's enrolment in the program. No enrolment after the start date of each program. Fees will not be pro-rated for any missed classes.
2. Fees will be refunded if two weeks' written notice of cancellation is received. Any refunds granted will be subject to a 15% administrative fee.
3. Central Eglinton Community Centre reserves the right to suspend any child from the program if s/he is disruptive to the other children and/or to the program.
4. A late fee of \$1.00 per minute will be charged for ALL LATE PICK UPS (after 5:30 p.m.).
